No. Codes-8/05 9471 /F, The Governor has been pleased to order that in the Delegation of Financial Power Rules, 1978 notified in Finance Deptt. Notification No. Codes-19/78-12000/F, dt. 9th March, 1978, the following amendment shall be inserted in Rule-13 as sub-rule-6 in order to avoid delay and expedite the execution of various infrastructure projects/developmental works financed under Backward District Initiative(BDI) of Rastriya Sam Vikash Yojana for according Administrative approval.

2. The enhanced power to accord administrative approval as indicated above is subject to the condition that while preparing the estimate for works, the current schedule of rate shall be taken into account. The estimate shall have to be countersigned by the authority competent to accord technical sanction as per para-6, 3, 2 of the OPWD Code, Volume-I. The provision for survey, investigation and quality control taken together shall be limited to of the work proper. The provision of contingency shall be taken normally at 1% of the work provision.

3. While according Administrative Approval to a project within the enhanced Delegated Financial Power indicated in Paragraph-1 above, the competent Authority shall see that the requirements as indicated in the check list annexed to this notification are fulfilled.

4. The existing Delegation of Financial Power in respect of works other than the works indicated in para-1 shall remain unchanged.
