Resolution

Subject: Revision of annual T.A. limit of Touring Officers.

Annual T.A. limits for the touring officials of the State were prescribed in F.D.'s Resolution No. 49941-T.A.-19/76/F., dtd. 30th October, 1976. In the meantime, Finance Department have revised the daily entitlements for different classes vide Finance Department O.M. No. 16638/F., dtd. 02.04.2011. Accordingly, the competent authority will assess the tour performance of the officers concerned and approve their tour particulars / tour diaries keeping in view the budget provision made for the purpose. The Government official concerned would be entitled to draw T.A. on the basis of their approved tour particulars and tour diaries at the approved rates. There will be no monetary ceiling on the T.A. entitlements of the officials. Their entitlements may be approved and disbursed subject to availability of budget provision.

This will take effect from the date of issue of the Resolution. Previous orders in this connection are superseded accordingly.


