Dear Siz,

I would like to invite your attention to the provision of Rule 11(1)(b) of GPF(Odisha) Rules, 1938 wherein it has been laid down that the amount of subscription shall be fixed by the subscriber himself, subject to the condition that it may be any sum not less than seven percent of his emoluments in case of Class-IV Govt. servant and not less than ten percent of his emoluments in case of any other Govt. servant and not more than his total emolument in any case. The emoluments for the purpose of subscription does not include dearness allowance.

However, instances have come to notice that the DDOs are allowing deduction of GPF subscription from the pay of the employees less than the prescribed percentage of Basic Pay & Grade Pay/more than the total of their Basic Pay & Grade Pay violating the above provision.

I shall be grateful, if you instruct all the DDOs not to allow an employee to subscribe to GPF either more or less than prescribed limit.
