Sub:- Constitution of the Committee for implementation of order dated 18.03.2015 of Hon'ble High Court of Odisha in WP(C) No-11830/2013 filed by Rohit Das Construction Pvt. Ltd.

Hon'ble High Court in their order dated 18.3.2015 passed on WP(C) No.11830 of 2013- M/s Rohit Das Construction Pvt Ltd -vrs- State and Others have declared the automatic enhancement of royalty on minor minerals made effective from 1.9.2010 as unlawful. The SLP filed by the State Government against the said decision has been dismissed by the Hon'ble Apex Court. Thus the order of Hon'ble High Court for refund or adjustment of the enhanced royalty against ongoing works will have to be implemented. Based on the recommendations of Committee, Works Department may issue the guidelines after due consultation with Finance Department / Law Department.

Now therefore the State Government has been pleased to constitute a Committee comprising the following members to prepare detailed guidelines on the verification procedure to be followed in pursuance of the direction of Hon'ble High Court for computing the amount of royalty eligible for reimbursement. Based on the recommendations of the Committee, Works Department may issue the guidelines after due consultation with Finance Department / Law Department.
