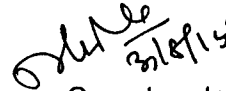

Annexure-I

Amendment to Para-3.5.9 & Note (I) thereof of OPWD Code, Volume-I

Para-3.5.9 - [Subject to the provision contained in Appendix-XXXIII to the OPWD Code, Volume-II], tenders should invariably be invited publicly in the manner prescribed in Appendix-IX to the Code and in Paragraph -3.5.10 below for all works given out on contracts and estimated to cost above Rs.5.00 lakh except in cases where additional works or items of work have to be undertaken as part of a scheme work for which tenders have originally been invited publicly and which are required to be executed while the work originally undertaken is in progress or for other exceptional reasons.

Annexure-II

Amendment to Note (I) to Para-3.5.9 of OPWD Code, Volume-I

Note (I) - Contract for works estimated to cost up to Rs.5.00 lakh may be given out with or without invitation of open tenders at the discretion of the Divisional Officers to the best advantage of Government. All other provisions remain unaltered.

Annexure-III

Amendment to Rule-I of Appendix-VII of OPWD Code, Volume-II.

Rule- I - Tenders shall ordinarily be invited for all works costing more than Rs.5.00 lakh. In case of urgency the prescribed period of notice may be suitably reduced.

Annexure-IV

Amendment to Rule-9 (b) of Appendix-IX of OPWD Code, Volume-II

Rule-9 (b) - The notice inviting tenders for works costing more than Rs.10, 000.00 but up to Rs.5.00 lakh should be circulated among the local offices. A copy of NIT should be sent to Contractors' Association (s), all Divisions of PWD within the District & concerned SEs Office.

Annexure-V

Amendment to Rule-9 (C) of Appendix-IX of OPWD Code, Volume-II

Rule-9 (C) – For all tenders costing more than Rs.5.00 lakh, the e-Tender route be adopted. Tenders for works costing more than Rs.5.00 lakh and up to Rs.10.00 lakh shall be published in two local Oriya News Papers. All other provisions remain unaltered.
