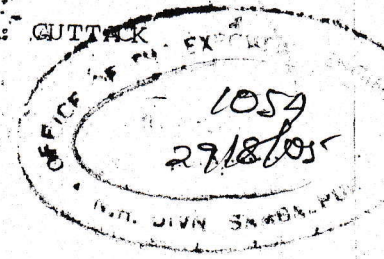

Sir,

In inviting a reference to the subject cited above, I am directed to say that under the Orissa Value Added Tax Act, a dealer is not entitled to undertake any contract with any Government, Local Authority or other Corporate body unless he obtains a clearance Certificate from the Commissioner to the effect that he has no liability to pay tax. This provision is applicable to regd. dealers. There is no provision for issue of non-assessment Certificate to a dealer under the Act. Hence, it is suggested that non-assessment Certificate may not be insisted upon from a person participating in a tender.

I therefore, request you to impress upon the Works Department not to insist upon non-assessment Certificate.
