Sub:- Amendment to Rule-13 of PWD Contractors Registration Rule, 1967 vide Works Department circular No.15543, dt.1.8.05- clarification for exemption of EMD.

Sir,

In inviting a reference to above subject, I am directed to say that exemption of E.M.D. has been allowed to Labour Co-operative Society vide Works Department resolution of 9185, dt.20.62 & No.4794, dt.20.3.65 which have not yet been withdrawn. Similarly, exemption of E.M.D. allowed to physically handicapped contractors, Engineer contractors, SC/St contractors (@50%) vide Works Department resolution no. 23934, dt.8.11.91, No.19078, dt.2.9.69, No. 27748, dt.11.10.77 respectively has not yet been withdrawn.

2- Works Department has issued circular No.15443, dt.1.8.05, which requires that all contractors for the purpose of participation in tenders have to deposit E.M.D @1%. As such there is doubt that whether contractors who were enjoying special category of exemption as stated above like labour co-operatives, engineer contractor, physically handicapped contractors etc. will continue to avail such exemption or not.

3- In this connection it is now clarified that exemption of E.M.D. allowed to various special category of contractors vide above resolutions of Works Department continues unless & until these circulars are specifically withdrawn/ amended.
