





ORDER

Sub: Relaxation in the procedure for determination of Remunerative Norms.

WHEREAS, Regulation 27 of the OERC Distribution (Conditions of Supply) Code, 2019 provides that the cost of extension of distribution main or its up-gradation up to the point of supply for meeting demand of a consumer, whether new or existing, and any strengthening/augmentation/up-gradation in the system starting from the feeding substation for giving supply to that consumer, shall be payable by the consumer or any collective body of such consumers as per norms fixed at Appendix-I. (i.e. Procedure for Determination of Remunerative norms).

WHEREAS, the EIC-Cum-PCEI, Government of Odisha has brought before the Commission that the Government of Odisha have desired to extend financial support for creation of distribution infrastructure for dedicated uninterrupted power supply to medical establishments, mega lift points, laying of underground cables etc.

WHEREAS, DISCOMs are responsible for system strengthening either through augmentation or up-gradation of its network, which is required to be recovered from the consumers through tariff. But, Government of Odisha desired to fund for such works without any additional burden to the consumers on this account.

WHEREAS, EIC-Electricity-cum-PCEI has requested to provide clarification on the preparation of estimate for the works which shall be supported by Government of Odisha to distribution companies for strengthening their system and to provide uninterrupted power supply for the benefit of the public in the state of Odisha.

Therefore, considering the proposed extension of financial support by Government of Odisha for strengthening of distribution infrastructure primarily to be used for the benefit of public of the State, it is hereby ordered that the applicability of 6% supervision charge at the time of preparation of cost estimate may be waived off in case of system strengthening projects funded by the Government of Odisha.

This is in exercise of the power conferred under Regulation 202 of OERC Distribution (Conditions of Supply) Code, 2019.

This order shall be implemented with immediate effect.
