Sub: Guidelines to execute the works costing to Rs 5.00 lakh by the Divisional officers with restriction on splitting of works limiting to Rs. 5.00 lakh along with execution of works of extremely urgent nature.

In adherence to the OPWD Code Vol.- I&II and Government of Odisha Works Department office Memorandum No.-10147, Dated 31-08-2015, Government in DoWR after careful consideration have been pleased to make the following guidelines on execution of works limiting to Rs 5.00 lakhs by the Divisional Officers with restriction on splitting of works limiting to Rs. 5.00 lakh along with execution of works of extremely urgent nature.

A. Splitting of works.

- i. A single work cannot be split up to number of works by framing individual estimates by changing Running Distance and by giving a gap between two adjacent works.
- ii. As far as possible, works executed in the same period and in the same location shall be clubbed up to one work.

B. Execution of works estimated up to Rs.5 lakhs vide Circular No - 10147/W Dt. 31.8.2015(amendment to 3.5.9 of OPWD Code).

Contracts for works estimated up to cost of 5 lakhs (Normal /emergent) shall be executed as under:-

"The total value of such works executed in a division shall be limited to 25% of the EOM funds not exceeding 1 crore in a year. All such works to be executed shall be approved by the concerned CE/CCE.

C. Execution of extremely urgent works through K2 agreement.

The works which are of urgent in nature like Test-Relief works, Cyclone/Flood Damage Repair, Closure of breaches in Canals / River embankments and Drainage congestion, when it is not possible in the interest of speedy execution of works to award contracts even by short tender may be executed as under:-

"Emergent works can be split up and awarded as per OPWD guide lines contained vide Appendix -VII, OPWD code Volume-II)".


*Violation of the above guidelines shall attract disciplinary action.
