**Sub:- Amendment to codal provision for execution of works under "AMA Hospital" initiatives.**

After careful consideration and in relaxation to Codal provision under Para 3.5.5 (V) & Para 6.3.17 of OPWD Code of Volume-I, Government have been pleased to delegate the power of sanctioning rates for extra/substituted items and for approving deviation in quantities in respect of a contract for execution of works under "AMA Hospital" Initiatives to the Divisional Officers (Superintending Engineer/Executive Engineer) of R&B /RW Divisions.

2. This delegation of power to the Divisional Officers shall be exercised subject to compliance of Codal provision under Note-(II) to Para 3.2.4 of OPWD Code of Volume-I and principles as laid down under Para 6.3.17 of OPWD Code, Volume-I. The Competent Authority for accordance of Administrative Approval to the projects under "AMA Hospital" Initiatives shall also be the Competent Authority for accordance of Revised Administrative Approval to the said projects.

3. The present delegation is specific to projects to be executed under "AMA Hospital" Initiatives and it shall come into effect from the date of issue of this Office Memorandum.

4. This has been concurred in by Finance Department in their File No. FIN-WF1-MISC-0050-2023.
