The question of providing certain facilities to Physically Handicapped persons to work as contractors was under active consideration Government have been pleased to decide that the following conditions may be given to Physically handicapped contractors.

- i) Any deaf or orthopaedically handicapped person having physical disability maximum upto 40 % who is considered capable of delivering goods properly may be enlisted as a contractor.
  - ii) Such Physically handicapped 'D', 'C' class contractors may be exempted from payment of E.M.D. and I.T.P.
  - iii) In relaxation of the procedure out lined in Appendix-XXXIII of the O.P.W.D. Code Vol.II, the Physically handicapped 'D'/'C' class contractors may be given 3% price preference on the rates quoted in their tenders. This preference will be allowed in respect of one or more works aggregating to Rs.50,000 in a financial year. The fact of availing of such price preference should be recorded year-wise on the reverse of the certificate of registration of the concerned physically handicapped 'D'/'C' class contractor by the tender accepting authority at the time of entering into agreement.
2. The above facilities would be available to physically handicapped contractors from the date of issue of this Resolution.
3. This issues with the concurrence of panchayat Raj Department and Finance Department in their U.OR.No.244-CD, dtd.30.11.80 and No.775-WP-1, dtd. 29.3.91 respectively.

After careful consideration Government have been pleased to decide that the following facilities may be given to Physically handicapped contractors.

- 1) Any deaf or orthopaedically handicapped person having physical disability maximum upto 40% who is considered capable of delivering goods properly may be enlisted as a Contractor.
- 2) Such physically handicapped 'D' / 'C' Class Contractors may be exempted from payment of E.M.D. and I.S.D.
- 3) In relaxation of the procedure out-lined in Appendix-XXXIII of the O.P.W.D. Code Vol-II, the Physically handicapped 'D' / 'C' Class Contractors may be given 3% Price preference on the rates quoted in their tenders. This preference will be allowed in respect of one or more works aggregating to Rs.50,000 to Rs.10,00,000 financial year. The fact of availing of such price preference should be recorded year-wise on the reverse of the certificate of registration of the concerned Physically handicapped 'D' / 'C' Class Contractor by the tender accepting authority at the time of entering in to agreement.
