It is, therefore, requested to furnish a detailed report in the matter in consultation with the Chief Engineers of this Department and the Sr. DAOs of some selected R&B and RD Divisions for taking further necessary action at this end.

Sub: Modification and alternation in WAMIS.

Sir,

In inviting a reference to the above mentioned subject, I am to state that a number of observations on recent modifications in respect of Supplementary Agreement have been received in this office from various Divisions. The difficulties facing by the Divisions due to the recent modification such as their inability to draw Supplementary Agreement in each case of quantity change even. In this context the clause 3.7.7, 3.11.1, 3.11.2 and 3.11.3 of OPWD code Vol-I and Index 5.20 of CPWD Works Manual 2019 may please be referred to. in which it is clarified that the Supplementary Agreement is required only in some specific cases. So mandatory of Supplementary Agreement not justifies the Codal provisions.

Hence, the C-DAC may please be suitably instructed to set the Supplementary Agreement as optional so that it can be drawn in case of requirement only.
