OFFICE MEMORANDUM

Sub.: Rate of deduction for use of official vehicle for journey from residence and back and for commuting from Bhubaneswar to Cuttack or vice versa and for private purpose

State Government had fixed the rate of deduction for using official vehicle for journey from residence and back, for commuting from Bhubaneswar to Cuttack or vice-versa and for private purpose vide FD OM No. 19541 dated 13.07.2016. In the meantime, more than 8 years have elapsed wherein fuel prices have increased significantly. Thus, it is felt necessary to revise existing rates of such deduction.

2. Therefore, the rates of deduction as provided in FD OM No. 19541 dated 13.07.2016 are hereby revised as given below.

(i) For using official vehicle for journey from residence and back

1	Secretaries/Additional Secretaries/ Heads of Department/ RDCs	Rs.1680/-	Rs. 2520/-
2	Officers of Administrative Departments and Heads of Department availing vehicle on pool basis	Rs.1120/-	Rs. 1680/-
3	Other Officers provided with official vehicles individually	Rs.1400/-	Rs. 2100/-
4	Collectors / ADMs & SPs	Rs. 1120/-	Rs. 1680/-

(ii) For using official vehicle for commuting from Bhubaneswar to Cuttack or vice versa

(a) The existing rate of deduction @ Rs. 6000/- per month, for use of official vehicle by Government officers commuting from Bhubaneswar to Cuttack or vice versa, shall remain unchanged.

(b) Wherever more than one officers, who are eligible for independent vehicles for commuting to Cuttack from Bhubaneswar or vice versa, wish to use one vehicle; the total deduction amount will be shared between them and collected accordingly. For example, if two officers eligible for independent vehicles, decide to use one vehicle for commuting from Bhubaneswar to Cuttack or vice versa; then Rs. 3000 (i.e., Rs. 6000 / 2) shall be recovered per month from each of them.

(iii) For using official vehicle for private purpose

Category of Govt. Officials	Limit of distance per month	Existing rate of deduction per month	Revised rate of deduction per month (w.e.f. 01.02.2025)
Secretaries and above / Additional Secretaries / Heads of Department / Collectors / IPS officers in the rank of IGP and above, IFS officers in the rank of CCF and above, IAS officers in the rank of Commissioner (not in the post of Head of Department viz. Consolidation Commissioner, Settlement Commissioner, Land Reform Commissioner, etc.)	(i) Upto 300 kms	Rs. 2520/-	Rs. 3780/-
	(ii) More than 300 kms and upto 500 kms	Rs. 4200/-	Rs. 6300/-
